## Summary of the Candidates for the Board of Directors- November 14, 2023

## **Agnes Samler**

Agnes Samler was Ontario's first independent Provincial Advocate for Children and Youth, holding that appointment in order to transfer the office from a Ministry base to a fully independent office reporting to the Legislature. Prior to this appointment Agnes was the executive director for Community Living Toronto for 12 years. She is a founding member and current President of Defence for Children International-Canada. Agnes has a long history in youth justice, beginning as a front line worker in a secure detention home, a probation officer, the Director in charge of training schools (secure custody institutions) in the north and east of the province, responsible for closing several of those institutions and replacing them with small community based group homes, and Administrator of Thistletown Regional Centre, a treatment centre for youth including those involved in the justice system. Agnes is deeply committed to ensuring that the voices of children and youth are heard and she is a strong supporter of the UN Convention on the Rights of the Child. Agnes has a BA in Psychology and a Master's Degree in Sociology and Criminology, both from the University of Toronto.

# Jane Stewart – B.Sc. (Hons.), J.D. – Litigation Lawyer

Jane is a staff litigation lawyer at Justice for Children and Youth, a legal clinic dedicated to advancing access to justice for children and young people in Ontario. Jane practices in all areas of the clinic's work, including youth criminal justice, education, and child protection and has appeared before all levels of court in Ontario as well as the Supreme Court of Canada, where she represented Justice for Children and Youth as an intervener on matters concerning the rights of children. This year, Jane is the Chair of the Ontario Bar Association's Child and Youth Law Section. Jane is currently on leave from JFCY to pursue an LLM focused on children and the law.

### Jason Maher

Jason has been a dedicated supporter for DCI Canada, contributing as a volunteer videographer and web designer for various DCI events, including the Annual Grant Lowery Lecture. Currently, he is taking a leading role in developing a new website for DCI-Canada.

Previously, Jason played a key role in advancing web technologies for Community Living Toronto. Notably, he was involved in the development of ConnectABILITY, an initiative aimed at connecting and supporting individuals with intellectual disabilities, their families, staff, donors, and the broader sector. Jason remains an integral part of the ongoing expansion of ConnectABILITY.
